Judging

A panel of three judges consisting of Hawaii Jewelers Association members or friends will judge each entry. The entries will be evaluated with equal emphases on the following criteria:

A) Overall Design B) Marketability C) Practicality/Wearability D) Craftsmanship

Each judge will award a maximum of 40 points to criteria A, Overall Design, and maximum 20 points each to the other three criteria for a maximum 100 points total on each entry. The points of the three judges are tallied and the highest point getter is the winning entry and so on for second and third places. The overall highest point getter will win **Designer of The Year**.

Awards

In each competition category, first, second and third place will receive Koa Framed award certificates. Also in each category popular choice will receive a Koa Framed award certificate. Awards will display beautifully in your business

HJA Jewelry Design Competition Rules

- 1) All jewelry must be original and have been designed by an HJA member who at the time of the competition is an HJA member in good standing.
- 2) The entry piece was produced within 18 months of the competition.
- 3) Only precious metals, (gold, silver or platinum) may be used.
- 4) All gem stones must be genuine. Any enhancement or treatments must be fully disclosed.
- 5) An individual may enter a maximum of one entry in each competition. There is no limit to the number of individual designers entering who are employed by the same firm.
- 6) All entrants waive any and all claims against the Hawaii Jewelers Association (HJA), its' individual members, officers or any HJA representative, associate or employee for any issue arising from the handling, condition, loss or theft of the jewelry being submitted for competition entry.
- 7) The entry articles be delivered on or before the cut off date at the location and date specified.
- 8) The entrant submits with their competition entry piece(s) a signed competition application form which signing of indicates that the entrant has reviewed, understands and agrees with all the competition rules.
- 9) Non refundable entry fees are paid in full to the Hawaii Jewelers Association on or before the entry cut off date.
- 10) The designer declare and clearly state the retail value or selling price of each piece entered.
